





Standard Install

Our standard install covers the significant majority of home installs in the UK and covers:

- Install of POD Point on a brick or plaster wall, or suitable permanent structure.
- The correct electrical connections and protections.
- An additional three way consumer unit, if required.
- Up to 15 meters of cable between the distribution board and the POD Point.
- Cable affixed flush to the wall, not trenched or hidden behind walls, through joists, arial or subterranean runs.
- Cable run through a single skin brick wall.
- An earth rod in soft ground, if required. Additional charges may apply if an earth rod must be fitted through hard standing.

Please note:

- We assume that your electrical connection is in adequate condition and has sufficient available capacity.
- If install requirements fall outside of our standard installation package, the electrician will detail required and provide a no obligation quote for these services.

POD Point Solos are covered by a comprehensive on-site hardware 36 month warranty. Any hardware failure should be promptly reported to us warranty@pod-point.com, quoting the serial number, the date of installation and a brief description of the fault. Home Charge Grant

The Office for Low Emission Vehicles (OLEV) provides a grant for EV drivers to have a POD Point installed at their home. POD Point will process and manage the application in order to claim the grant for you.

The grant is subject to a number of terms and conditions, a summary of which is provided in this document.

Summary of Terms and Conditions

- Residents must provide evidence of being the registered keeper or lessee, or be named as the primary user of an eligible plug-in vehicle in order to be able to claim the grant.
- Only one claim per vehicle can be made, even if you own more than one home. However, a single customer can claim one charge point per vehicle, for up to two vehicles.
- A list of qualifying electric vehicles is maintained at: https://www.gov. uk/plug-in-car-van-grants/eligibility.
- The grant is only applicable for residential addresses with designated private off-street parking.
- If you are not the property owner, written permission from the property owner must be obtained prior to installation of the charge point.
- The charge point must be installed in a location with GSM coverage and usage data collected will be passed to OLEV in an anonymized form to inform future decisions.
